

section A – AL G-17 ESInet overview

- **1. Work continues to refine the design of the G-17 ANGEN network.** We have made good progress in several key areas.
 - a. The first test call was completed on September 12th, utilizing the NGCS stack.
 - b. Failover testing is in progress. Expected to be completed this week.

2. ANGEN 2.0/G-17 buildout

- a. Redundant ESi-Net connection have been ordered at Winfield SR region and Wiregrass region.
- *b. Agencies with pending ESi-Net connections:* Butler, Coffee, Covington, Crenshaw, Dale, Daleville, Dothan, Enterprise, Geneva, Henry(2), Fayette, Lamar, Marion, Pickens, Winston, Franklin, Conecuh.
- c. Expecting the first Wireless call to utilize ANGEN2.0 network in October. (Bandwidth Conversion)
- d. Centurylink Wireline services orders are in process.
 Facilities have been ordered, trunk turnup is 30 to 60 days out.

section B - industry stakeholders

- **3. Emergency Call Works -** INdigital has completed a software upgrade of NGCS to support SIP INFO transfers. We are now ready to support Wiregrass and other ECW installations throughout the state.
 - a. Conversion planning for Wiregrass PSAPs is expected to begin immediately.

4. Originating Service Provider status -

- a. INdigital has begun to order facilities to ATT SR from ANGEN datacenters.
- **5. PSAP Outreach -** Team is focusing efforts now on the initial turn ups. Additional outreach will begin in coordination with the Gulf Coast Conference.
- **6. Adjacent state connectivity** INdigital has received 911 system service provider certification in Florida, Mississippi, and Georgia. Tennessee is still pending. (no update for this element of the project.)
- **7. Regulatory matters** Nothing to report.
- **8. Inter-agency agreements** Nothing to report.
- 9. Other stakeholders Nothing to report.

Finance Committee Report **CAPITAL PURCHASES & CAPITALIZATION THRESHOLD POLICY**

This policy was approved by the Alabama Statewide 911 Board of Directors on ______ and will become effective for all purchases after October 1, 2017.

Definition and Threshold:

Capital purchases comprise furniture, fixtures, equipment, software, leasehold improvements, etc. that meet two criteria:

a useful life of more than one year, <u>and</u>
 cost more than a certain amount.

The Alabama Statewide 911 Board of Directors has established \$1,000.00 as the threshold amount for capitalization.

Recordkeeping:

The Alabama Statewide 911 Board shall maintain a list of fixed assets showing the date of the acquisition, its cost, and a schedule for depreciation of the asset. The Alabama Statewide 911 Board shall keep on file documentation for each purchase.

For each purchase, the Director shall evaluate whether the acquisition will have an impact on insurance coverage, determine if present coverage valuations are adequate, and obtain additional coverage if necessary.

Finance Committee Report Recommendations

- Distribution and allocation of funds in various accounts:
 - To distribute the balance in the Examiners to the Emergency
 Communication Districts (ECDs) by population = \$788,770.76
 - To declare a portion of the FY17's Cost Recovery/ANGEN balance as excess and distribute to the Emergency Communication Districts (ECDs) by population = \$967,842.40, and
 - -Allocate a portion of the balance of the Operating Account for the Training and Grant Programs, specifically citing that ANGEN-readiness should be a priority among the Committee in evaluating any grant applications from ECDs =**\$1,726,584.67**.


