Dear ECD Director,

Please find included the monthly statement of the distribution of the Alabama 9-1-1 Fund.

The table below represents the 9-1-1 Fund as a whole for collections in the month of April 2024 scheduled for distribution in the month of May 2024. Your District’s portion of these funds will be made available in your account May 17, 2024. This month’s distribution contains an adjustment of your monthly baseline for carriers that have remitted at the \$1.86 rate (0.48%) as well as those that remitted at the most recent surcharge rate of \$2.23(99.52%). Additionally, the Department of Revenue now remits at the \$2.23 rate. We continue to expect these percentages to adjust monthly over the next month or so until all carriers are compliant with the current surcharge. The breakdown can be found on the following pages and there will be only one ACH transaction for the monthly distribution.
