The Position in Brief

The Blount County Communications District (Blount County 911) is seeking a 911 Operations Manager. Located in the heart of beautiful Oneonta, Alabama, nestled in the midst of the Appalachian Mountains, the Blount County Communications District is a consolidated dispatch center serving Blount County and the City of Leeds, Alabama.

The Organization:

The mission of Blount County 911 is to work cooperatively with public safety agencies to provide a safe environment for residents and visitors within our communities. This will be accomplished through providing our personnel with the highest levels of training and leveraging the latest technologies available. In every endeavor, Blount County 911 will strive to provide the highest level of customer service and hold fast to our core beliefs of trust, resilience, compassion and professionalism. In carrying out our mission, we recognize that service is our one and only product and the individual and unique contributions of each of us working in a spirit of cooperative team work is intrinsically tied to the service we provide; both to public safety associates within and outside of the Blount County 911 service area, and the members of our respective communities.

The Blount County Communications District was established in 1993 and provides 911 services for all Law Enforcement, Fire and Emergency Medical Services throughout Blount County and the City of Leeds, Alabama. Blount County 911 has a service area of approximately 673 square miles, and serves a total population of approximately 71,312.

As a consolidated public safety answer point (PSAP), Blount County 911 serves a total of 36 partner agencies, comprised of Law Enforcement, Fire and EMS (Emergency Medical Services). Our state-of-the-art facility was designed and built in 2014 and is still one of the most advanced PSAPs in our region and state. Blount County 911 receives over 87,000 Calls for Service (CFS) per year that result in first responders being dispatched and additionally handles an immense volume of non-dispatched calls for the communities and agencies we serve. The Blount County Communications District has an approved annual budget of 2.1 million that serves to support the operations and technology requirements of the center and has an approved staffing number of 24, including the Operations Manager position.

- Possess a comprehensive knowledge of the principles, practices and regulations pertaining to 911 systems with a proven track record in a progressive, consolidate communications system of a similar size or larger.
- Demonstrated leadership skills including building relationships while holding people accountable by adhering to policies and standards.
- A history of increasingly responsible experience in an operational public safety communication position with experience in a supervisory or administrative capacity, preferably in a multi position, multi-jurisdictional environment.
- A Bachelor's degree in public safety communications or a related field (preferred) A degree in technology may also be considered as well as a combination of experience and skills will be evaluated on a case-by-case basis.
- Essential skills in the areas of project and personnel management, budget development and administration, financial oversight, long range financial planning, training, 911 system design, maintenance, and operations of equipment, including Computer Aided Dispatch (CAD) software, hardware and process.
