
585-X-4-.05 Lifeline Service Collection Of 9-1-1 Service Charge.


(1) Any telecommunications carrier that has been designated and certified as an Eligible Telecommunication Carrier (ETC) by the F.C.C. and the Universal Services Administrative Co. (USAC) to offer Lifeline service shall collect from any Lifeline subscriber, the monthly 9-1-1 service charge and remit the monthly collections to the Board pursuant to Sections 37-2A-7 or 11-98-5, Code of Ala. 1975.

(2) A CMRS provider which has been designated as an ETC shall collect from any Lifeline subscriber, the monthly 9-1-1 service charge and remit the monthly collections to the Board pursuant to Section 11-98-5(a), Code of Ala. 1975.

(3) "Lifeline Subscriber" means a customer who meets the income eligibility tests and requirements established by the Alabama Public Service Commission and USAC and receives telecommunication services wherein the customer is capable of receiving voice communication service that is technically capable of accessing a 9-1-1 system.


The Alabama Statewide 911 Board is authorized to adopt procedures, rules and regulations as may be necessary to establish a statewide 9-1-1 charge, and to apply, collect the statewide 9-1-1 charge and distribute the funds from the 9-1-1 Fund, and otherwise take action to efficiently and effectively ensure the delivery of 9-1-1 services within the State of Alabama. The Statewide 911 Board is also authorized to adopt rules and regulations to fund advisory services, grants, and training for emergency communication districts within the State of Alabama.



585-X-2-.03 Voting

(1) In order for the Board to conduct business at a meeting a quorum must be established. A quorum shall consist of a majority of those members appointed to the board.

(2) Voting by electronics means is not allowed. In order to vote a Board member must be present. Proxies are not allowed. All voting of the 9-1-1 Board shall be conducted in accordance with the Alabama Open Meetings Act.


(3)All voting shall be taken in open session. Secret ballots are not allowed. There shall be no deliberations done in executive sessions.




(4) Calendar.

(a) The <u>BordBoard</u> will establish and advertise the application period for each grant cycle. Review of applications will take place for thirty (30) days after the application period ends, and grants, if any, will be awarded at the next regularly scheduled Board meeting after the review is completed. An application not funded in a grant cycle must be resubmitted in order to compete again in a subsequent grant cycle.

(b) Any ECD seeking grant funding for hardships or consolidation may petition the Board at any time, regardless of the aforementioned calendar.











585-X-4-.09 Additional Distributions To Emergency Communication Districts From The Cost Recovery Fund.

(1) The Board recognizes that it is of utmost importance that each Emergency Communication District (ECD) validly formed and operating within the State of Alabama as of September 30, 2011, at a minimum, be made whole, as contemplated by the passage of Act 2012-293 and adoption of the statewide 911 charges heretofore made.

(2) The Board acknowledges that under the current funding mechanism that some ECDs may not be made whole by the current base distribution amount and per capita distribution. Under Section 11-98-5(f) Code of Ala. 1975, as amended, in the event the Board determines that revenues allocated to reimbursement of CMRS providers for cost recovery is sufficient, then in that event, the Board may, at its discretion, distribute those excess revenues for the benefit of the ECDs currently existing and operating within the state.

(3) In the event an ECD is not made whole by virtue of its base distribution amount and per capita distribution, and if there are funds available in the Cost Recovery Fund over and above amounts sufficient to reimburse providers for cost recovery, then and in that event, the Board may make such ECD whole by use of funds from the Cost Recovery Fund.

(4) If, after payments to ECDs in order for them to be made whole and payment of cost reimbursement to CMRS providers, there are funds available in the Cost Recovery Fund, then and in that event, the Board shall make payments on behalf of or to all <u>contractors, ECDs, and PSAPs</u> to all vendors for costs related to the deployment and operation of a statewide 9-1-1 voice and data system and to train and certify public safety telecommunicators employed by primary PSAPs.

(5) If possible, after payments to ECDs in order for them to be made whole, payment of cost reimbursement to CMRS providers, and payments of costs related to the deployment and operation of a statewide 9-1-1 voice and data system, and payments for the training and certification of public safety telecommunicators employed by primary PSAPs, the Cost Recovery Fund shall at all times maintain a minimum balance equal to one hundred and eighty (180) days operational and administrative costs of the board, which includes payments to all vendorsninety (90) days operational and administrative costs of the board, which includes payments to all contractors and costs related to the deployment and operation of a statewide 9-1-1 voice and data system and to train and certify public safety telecommunicators employed by primary PSAPs, plus up to one-twelfth (1/12) of the annual baseline due to ECDs.

(6) If possible, after payments to ECDs in order for them to be made whole, payment of cost reimbursement to CMRS providers,

payments of costs related to the implementation and operation of the next generation statewide 9-1-1 call delivery network and certification of public safety telecommunicators employed by primary PSAPs, and the Cost Recovery Fund has a minimum of 1890 days of operational and administrative costs of the board as stated in Paragraph 5, then the Board may, in its discretion, set aside an amount from the Cost Recovery Fund to fund the Board's advisory, training, and grant programs as contemplated by Sec. 11-98-4.1 Code of Ala. 1975, as amended, and Rules 585-X-2-.07 and 585-X-2-.08.

(7) If after compliance with (3), (4), (5), and (6) above, the Board will review the balance in the Cost Recovery Fund beginning in November 2018 and at least annually thereafter, to determine if there are additional funds that may be distributed to the ECDs. If the Board determines there are additional funds for distribution, then any distribution the Board makes from the Cost Recovery Fund shall be done on the following basis:

(a) One half (1/2) of the total amount the Board determines that may be distributed to the ECDs shall be made to each ECD formed and validly operating as of September 30, 2011 and which is currently existing and operating within the state, based on the distribution formula used when calculating the per capita distribution amount due a particular ECD.

(b) One half (1/2) of the total amount the Board determines that may be distributed to the ECDs shall be made in equal parts to each ECD which was formed and operating as of September 11, 2011 and which is currently existing and operating within the state.

(8) In the event two or more ECDs have consolidated during the preceding fiscal year or consolidated before a Board decision regarding additional distributions to ECDs in November, then if a distribution is made, the distribution that an ECD would have received prior to consolidation shall be made to the consolidated, surviving ECD.









Statement of Revenue and Expenses - Modified Cash Basis Total Funds

Legacy Cost Reimbursement: ECD Reimbursements and Board Direct Billed











Reminder of the ECD Self-Report Due to the Examiners of Public Accounts


FY24 Cost Recovery Summary




COST RECOVERY - ALL Previous year's Plan versus Actual versus Current Year's plan



Texty Authentication Tokens will expire at the end of May so all sites remaining on Texty will need to be tested for the Texty OTP Authentication.




ANGEN Total Call Count February 12, 2018 - October 31, 2024

Currently, we are georouting wireless calls in the state utilizing only the PSAP boundaries. We have begun testing has begun Location Validation Function (LVF) and MSAG Conversion Service using Marengo County's set of NENA required GIS datasets.


GIS Update



- The Location Validation Function will ultimately replace the MSAG/ALI comparisons that carriers currently use.
- The GIS data will replace the MSAG and become the standard in which carriers will use to determine if location information is valid. The MSAG Conversion Service converts MSAG formatted ALI into the newer form of PIDF-LO based ALI for those PSAPs who have not upgraded their call handling equipment to accept this new type of location information, and vice versa.

This is one of the first steps testing our functional elements, as we move towards utilizing all GIS data from the state as well as georouting all calls in the state.

Helping Our Neighbors



Through the use of Starlinks and MEVO Anywhere Kits, Alabama 911 was able to restore 911 services to 9 911 Centers in Georgia following Hurricane Helene.

Henry County and Walker County both shared their MEVO Anywhere Kits. The AL 911 Board loaned 2 Starlinks and 2 MEVO Anywhere Kits. INdigital deployed additional kits, Starlinks and personnel to assist in connectivity.

585-X-4-.09 Additional Distributions To Emergency Communication Districts From The Cost Recovery Fund.

(1) The Board recognizes that it is of utmost importance that each Emergency Communication District (ECD) validly formed and operating within the State of Alabama as of September 30, 2011, at a minimum, be made whole, as contemplated by the passage of Act 2012-293 and adoption of the statewide 911 charges heretofore made.

(2) The Board acknowledges that under the current funding mechanism that some ECDs may not be made whole by the current base distribution amount and per capita distribution. Under Section 11-98-5(f) Code of Ala. 1975, as amended, in the event the Board determines that revenues allocated to reimbursement of CMRS providers for cost recovery is sufficient, then in that event, the Board may, at its discretion, distribute those excess revenues for the benefit of the ECDs currently existing and operating within the state.

(3) In the event an ECD is not made whole by virtue of its base distribution amount and per capita distribution, and if there are funds available in the Cost Recovery Fund over and above amounts sufficient to reimburse providers for cost recovery, then and in that event, the Board may make such ECD whole by use of funds from the Cost Recovery Fund.

(4) If, after payments to ECDs in order for them to be made whole and payment of cost reimbursement to CMRS providers, there are funds available in the Cost Recovery Fund, then and in that event, the Board shall make payments on behalf of or to all <u>contractors, ECDs, and PSAPs</u> to all vendors for costs related to the deployment and operation of a statewide 9-1-1 voice and data system and to train and certify public safety telecommunicators employed by primary PSAPs.

(5) If possible, after payments to ECDs in order for them to be made whole, payment of cost reimbursement to CMRS providers, and payments of costs related to the deployment and operation of a statewide 9-1-1 voice and data system, and payments for the training and certification of public safety telecommunicators employed by primary PSAPs, the Cost Recovery Fund shall at all times maintain a minimum balance equal to one hundred and eighty (180) days operational and administrative costs of the board, which includes payments to all vendorsninety (90) days operational and administrative costs of the board, which includes payments to all contractors and costs related to the deployment and operation of a statewide 9-1-1 voice and data system and to train and certify public safety telecommunicators employed by primary PSAPs, plus up to one-twelfth (1/12) of the annual baseline due to ECDs.

(6) If possible, after payments to ECDs in order for them to be made whole, payment of cost reimbursement to CMRS providers,

payments of costs related to the implementation and operation of the next generation statewide 9-1-1 call delivery network and certification of public safety telecommunicators employed by primary PSAPs, and the Cost Recovery Fund has a minimum of 1890 days of operational and administrative costs of the board as stated in Paragraph 5, then the Board may, in its discretion, set aside an amount from the Cost Recovery Fund to fund the Board's advisory, training, and grant programs as contemplated by Sec. 11-98-4.1 Code of Ala. 1975, as amended, and Rules 585-X-2-.07 and 585-X-2-.08.

(7) If after compliance with (3), (4), (5), and (6) above, the Board will review the balance in the Cost Recovery Fund beginning in November 2018 and at least annually thereafter, to determine if there are additional funds that may be distributed to the ECDs. If the Board determines there are additional funds for distribution, then any distribution the Board makes from the Cost Recovery Fund shall be done on the following basis:

(a) One half (1/2) of the total amount the Board determines that may be distributed to the ECDs shall be made to each ECD formed and validly operating as of September 30, 2011 and which is currently existing and operating within the state, based on the distribution formula used when calculating the per capita distribution amount due a particular ECD.

(b) One half (1/2) of the total amount the Board determines that may be distributed to the ECDs shall be made in equal parts to each ECD which was formed and operating as of September 11, 2011 and which is currently existing and operating within the state.

(8) In the event two or more ECDs have consolidated during the preceding fiscal year or consolidated before a Board decision regarding additional distributions to ECDs in November, then if a distribution is made, the distribution that an ECD would have received prior to consolidation shall be made to the consolidated, surviving ECD.







(b) Effective October 1, 2013, there shall first be deducted, no more than one time during each calendar month, from the total amount of the statewide 911 charges paid over to the 911 Board during such month, a sum not to exceed one three percent of the total amount, to be applied by the 911 Board exclusively for payment of administrative expenses theretofore incurred by it_and, at the board's discretion, the awarding of additional operational grants to districts outside of the other distribution criteria in this subsection upon a showing of hardship. The balance of the total amount of the statewide 911 charges paid over to the 911 Board during each calendar month shall be deposited into the 911 Fund and shall be apportioned and distributed in accordance with the succeeding provisions of this subsection.

(1) There shall be distributed each month among all then existing districts, from the moneys then on deposit in the 911 Fund, an aggregate amount equal to <u>80 percent</u> the sum of a. 80 percent of the portion of the statewide 911 charges remitted to the 911 Board with respect to the month by CMRS providers and for prepaid wireless 911 charges, plus b. 100 percent of all other the statewide 911 charges remitted to the 911 Board with respect to the month.


(2) There shall be paid each month to each then existing district, out of the amount described in subdivision (1), one-twelfth of the sum of the base distribution amount defined, as applicable, in subdivisions (3) and (4), plus the per capita distribution amount defined in subdivision (5).



At any time after [earliest date previous subsection goes into effect, assuming a date is needed], should the 911 Board determine that the revenues allocated to the separate account under subdivision (7) of subsection (b) of Section 11-98-5.2 exceed those necessary to meet funding requirements, it may distribute any excess revenues in equal parts to districts which were formed and validly operating as of September 30, 2011 and which are currently existing and operating within the state.






Travel Policy (11-98-4.1)

(d) For all terms expiring after June 1, 2014, the governmental entities or industry groups identified in subsection (b) shall recommend at least two different persons for each board position for which they are charged with making a recommendation, with the Governor appointing a member from among such recommended candidates. For all terms expiring after July 1, 2015, appointments made by the Governor shall be subject to confirmation by the Senate as provided in this subsection. Appointments made at times when the Senate is not in session shall be effective immediately ad interim and shall serve until the Senate acts on the appointment as provided herein. Any appointment made while the Senate is not in session shall be submitted to the Senate not later than the third legislative day following the reconvening of the Legislature. In the event the Senate fails or refuses to act on the appointment, the person whose name was submitted shall continue to serve until action is taken on the appointment by the Senate.


